Alabama State Board of Public Accountancy Minutes of Board Meeting September 16, 2021

1. <u>Date, Place and Attendance of Meeting:</u>

A regular meeting of the Alabama State Board of Public Accountancy was held on Thursday, September 16, 2021, in the Board office, located in Montgomery, Alabama at 10:00 a.m.

A lawful quorum of the Board was present for the meeting.

Also present were D. Boyd Busby, Executive Director; Billington M. Garrett, General Counsel; Kathy Brown, Governmental Hearing Officer; Amy Thompson, Senior Accountant; Teresa Taylor, Enforcement Coordinator; and Nicole Robinson, CPE Administrator.

Sufficient prior notice of the meeting had been given as required by the Alabama Open Meetings Act.

2. Call to Order:

The meeting was called to order by Dr. Steve Grice, CPA, Chair.

3. Approval of Agenda:

Mr. Blackmon made a motion to approve the agenda as presented for the September 16, 2021 meeting. Mr. Madison seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Blackmon, Grice, Kintz, Madison, and Mses. Prince and Sheppard-Harris.

4. Election of Officers:

Mr. Blackmon nominated Ms. Sheppard-Harris, Chair; Mr. Schaffers, Vice Chair and Mr. Madison, Secretary. Mr. Kintz seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Blackmon, Grice, Kintz, Madison, and Mses. Prince and Sheppard-Harris. The newly elected officers acceded to their respective offices immediately.

5. Approval of Minutes:

Dr. Grice made a motion to approve the minutes of the July 16, 2021 meeting. Mr. Blackmon seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Blackmon, Grice, Kintz, Madison, and Mses. Prince and Sheppard-Harris.

Due to the unavailability of Ms. Kathy Brown, Esq., Governmental Hearing Officer, items not requiring her presence were moved in front of the hearings to accommodate her schedule.

6. Requests for Reinstatement:

a. <u>Erin Elizabeth Haley, Certificate No. 12508:</u>

Mr. Busby presented a letter from Erin Elizabeth Haley, CPA Certificate No. 12508, requesting reinstatement to inactive status. Her reinstatement request included all the completed forms and fees that the Board had decided would be necessary to gain favorable consideration for reinstatement. Ms. Haley did not attend the hearing and it was conducted in her absence. Ms. Haley's written request included the required assertion on felonies, a completed 2020-2021 personal registration form, evidence of completion of the NASBA CPT Ethics Training course, and payment in the amount of \$1,150. The payment comprised the \$100 reinstatement fee, \$500 administrative fine, \$500 late renewal penalty for the fiscal year 2020-2021, and \$50 registration fee for the fiscal year 2020-2021. After discussion, Mr. Madison made a motion to reinstate Ms. Haley's CPA Certificate No. 12508 to inactive status. Ms. Prince seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Blackmon, Grice, Kintz, Madison, and Mses. Prince and Sheppard-Harris.

b. Eric Love, Certificate No. 6328:

Mr. Busby presented a letter from Eric Love, CPA Certificate No. 6328, requesting reinstatement to active status. His reinstatement request included all the completed forms and fees that the Board had decided would be necessary to gain favorable consideration for reinstatement. Mr. Love did not attend the hearing and it was conducted in his absence. Mr. Love's written request included the required assertion on felonies, evidence of completion of Peer Review, evidence of completion of the NASBA CPT Ethics Training course, and payment in the amount of \$100. The payment comprised the \$100 reinstatement fee. After discussion, Mr. Madison made a motion to reinstate Mr. Love's CPA Certificate No. 6328 to active status. Dr. Grice seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Blackmon, Grice, Kintz, Madison, and Mses. Prince and Sheppard-Harris.

Nicholas Lamar MacDonald, Certifícate No. 6306-R:

Mr. Busby presented a letter from Nicholas Lamar MacDonald, CPA Certificate No. 6306-R, requesting reinstatement to active status. His reinstatement request included all the completed forms and fees that the Board had decided would be necessary to gain favorable consideration for reinstatement. Mr. MacDonald did not attend the hearing and it was conducted in his absence. Mr. MacDonald's written request included the required assertion on felonies, a

completed 2020-2021 personal registration form, evidence of completion of required catch-up CPE, evidence of completion of the NASBA CPT Ethics Training course and payment in the amount of \$2,775. The payment comprised the \$100 reinstatement fee, \$2,000 administrative fine, \$500 late renewal penalty for the fiscal year 2015-2016, and \$175 registration fees for fiscal years 2015-2016 and 2020-2021. After discussion, Dr. Grice made a motion to reinstate Mr. MacDonald's CPA Certificate No. 6306-R to active status. Ms. Prince seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Blackmon, Grice, Kintz, Madison, and Mses. Prince and Sheppard-Harris.

d. Jason Eric Schmitt, Certificate No. 10678:

Mr. Busby presented a letter from Jason Eric Schmitt, CPA Certificate No. 10678, requesting reinstatement to active status. His reinstatement request included all the completed forms and fees that the Board had decided would be necessary to gain favorable consideration for reinstatement. Mr. Schmitt did not attend the hearing and it was conducted in his absence. Mr. Schmitt's written request included the required assertion on felonies, a completed 2020-2021 personal registration form, a written explanation of the type of accounting services provided since last licensed, a completed Citizenship form, and payment in the amount of \$4,775. The payment comprised the \$100 reinstatement fee, \$4,000 administrative fine, \$500 late renewal penalty for the firm registration for the fiscal year 2010-2011, \$75 firm registration fee for the fiscal year 2010-2011, and \$100 personal registration fee for fiscal year 2020-2021. After discussion, Mr. Madison made a motion to reinstate Mr. Morrison's CPA Certificate No. 7242 to active status. Ms. Prince seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Blackmon, Grice, Kintz, Madison, and Mses. Prince and Sheppard-Harris.

e. John Anthony Morrison, Certificate No. 7242:

Mr. Busby presented a letter from John Anthony Morris, CPA Certificate No. 7242, requesting reinstatement to active status. His reinstatement request included all the completed forms and fees that the Board had decided would be necessary to gain favorable consideration for reinstatement. Mr. Morrison did not attend the hearing and it was conducted in his absence. Mr. Morrison's written request included the required assertion on felonies, a completed 2020-2021 personal registration form, evidence of completion of required catch-up CPE, evidence of completion of the NASBA CPT Ethics Training course and payment in the amount of \$2,700. The payment comprised the \$100 reinstatement fee, \$2,000 administrative fine, \$500 late renewal penalty for the fiscal year 2019-2020, and \$200 registration fees for fiscal years 2019-2020 and 2020-2021. After discussion, Mr. Madison made a motion to reinstate Mr. Morrison's CPA Certificate No. 7242 to active status. Ms. Prince seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Blackmon, Grice, Kintz, Madison, and Mses. Prince and Sheppard-Harris.

7. Approval of April-May-June 2021 CPA Examination Grades:

The Board was presented with the AICPA Advisory Grades for the April through June 2021 Uniform CPA Examination. After review, Mr. Blackmon made a motion to approve the grades as released to candidates. Mr. Kintz seconded and the motion carried unanimously.

8. Approval of new CPA Certificates from 14336 through 14381-R:

Mr. Blackmon made a motion to approve new CPA Certificates No. 14336 through 14381-R. Mr. Madison seconded and the motion carried unanimously.

9. Approval of Waiver of Exam, Reciprocal and Transfer of Grades Application Fees

Dr. Grice made a motion that the Board waive all application fees for the CPA Exam, Reciprocal Certificates, and Transfer of Grades effective January 1, 2022 until December 31, 2022. Mr. Madison seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Blackmon, Grice, Kintz, Madison, Schaffers, and Mses. Prince and Sheppard-Harris. The Board agreed to review the possibility of a waiver or reduction of this fee annually.

10. Approval of FY2021-2022 Operating Calendar:

The Board was presented with the 2021-2022 Operating Calendar. After review, Mr. Blackmon made a motion to approve the 2021-2022 Operating Calendar as presented. Mr. Madison seconded and the motion carried unanimously.

11. Approval of FY2022-2023 Annual Budget:

Mr. Madison made a motion to approve the FY2022-2023 Annual Budget. Mr. Blackmon seconded and the motion carried unanimously.

12. Approval of Compensation Plan:

Mr. Kintz made a motion to approve the proposed Compensation Plan. Mr. Madison seconded and the motion carried unanimously.

13. Alabama CPA Examination Statistics:

A statistical summary of the Alabama CPA Examination was presented to the Board. A brief discussion ensued but no action was taken.

14. Peer Review Delinguencies Update:

A statistical summary of Delinquent Peer Reviews as of December 31, 2020 was presented to the Board. A brief discussion ensued but no action was taken.

15. Complaints Update:

A complaints summary for FY 2009-2010 through 2020-2021 was presented to the Board. A brief discussion ensued but no action was taken.

16. Licensee Count:

A statistical summary of the number of Board licensees by category was presented to the Board. A brief discussion ensued but no action was taken.

17. Executive Director's Update & Report on Activities:

(a) Retirement:

Mr. Busby informed the Board that after 32 years with the Board, Anna Baker is retiring on January 1, 2022. Mr. Busby also informed the Board that Alise Ellis has accepted the position of CPA Exam Coordinator.

(b) NASBA Annual Meeting

Mr. Busby informed the Board that the NASBA Annual meeting will be held virtually.

(c) New Database

Mr. Busby informed the Board that the Board staff along with OIT were working to develop a new licensee database.

(d) Subpoena Received

Mr. Busby informed the Board that the Board had received a Civil Subpoena for records for a complaint case where the investigative committee ruled no probable cause. Mr. Busby informed the Board that Board Attorney Bill Garrett had drafted a motion to quash and filed it with the court on September 9, 2021.
