Alabama State Board of Public Accountancy Minutes of Board Meeting July 12, 2024

1. Date, Place and Attendance of Meeting:

A regular meeting of the Alabama State Board of Public Accountancy was held on Friday, July 12, 2024, at the Board's office located in Montgomery, Alabama at 10:00 a.m.

A lawful quorum of the Board was present for the meeting.

Also present were D. Boyd Busby, Executive Director; Billington Garrett, Board Attorney; Nicole Robinson, Chief of Staff; Teresa Taylor, Enforcement Coordinator; Ashley Sides, CPE Administrator; and Kathy Brown, Administrative Law Judge. Ms. Anna Chancellor was in attendance for the hearing portion of the meeting.

Ms. Prince was delayed due to traffic until 10:09 AM.

Sufficient prior notice of the meeting had been given as required by the Alabama Open Meetings Act.

2. Call to Order:

The meeting was called to order by Mr. Michael Kintz, CPA, Chair.

Approval of Agenda:

Ms. Sheppard-Harris made a motion to approve the agenda for the July 12, 2024 meeting. Mr. Smith seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Ms. Sheppard-Harris.

4. Approval of Minutes:

Mr. Smith made a motion to approve the minutes of the May 3, 2024 meeting. Ms. Sheppard-Harris seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Ms. Sheppard-Harris.

5. Disciplinary Hearings:

a. Case No. 24-7 – Marion E. Higgins Jr, Cert. 2399:

Ms. Kathy Brown, Esq., Governmental Hearing Officer served as hearing officer and presided over the disciplinary hearing for Mr. Marion E. Higgins, Jr. Mr. Higgins did not attend the meeting and the hearing was conducted in his absence. At the conclusion of the hearing, Mr. Smith made a motion that the Board accept the consent agreement as presented. Mr. Etheredge seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Ms. Sheppard-Harris. The Board's Order, Summons and Complaint, and the transcript of the hearing are attached and become a part of these minutes.

6. <u>Disciplinary Hearings on Delinquent 2023-2024 Annual Registrations:</u>

Mr. Kintz turned the meeting over to Ms. Kathy Brown, Esq., Governmental Hearing Officer, to serve as hearing officer and preside over the disciplinary hearings for licensees with delinquent 2023-2024 annual registrations. None of the respondents attended the hearings and the hearings were conducted in their absence. At the conclusion of the hearings, Mr. Schaffers made a motion that the Board find each respondent listed on Board Exhibit No.1, with the exclusion of Peggy Wall's individual license and firm, guilty of all charges in the Summons and Complaints. He further moved that the license, registration, certificate and/or permit to practice of each of the respondents listed on Board Exhibit No. 1 be revoked, that each respondent be fined \$500 and that each respondent return the revoked certificate and/or permit to practice to the Board office within 30 days of this date. Mr. Smith seconded, and the motion carried unanimously on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Mses. Prince and Sheppard-Harris. 7. Requests for Reinstatement:

a. Margaret Burks Hammond, Certificate No. 6611:

Mr. Busby presented a letter from Margaret Burks Hammond, CPA Certificate No. 6611, requesting reinstatement to active status. Her reinstatement request included all the completed forms and fees that the Board had decided would be necessary to gain favorable consideration for reinstatement. Ms. Hammond did not attend the hearing and it was conducted in her absence. Ms. Hammond's written request included the required assertion on felonies, a completed 2023-2024 personal registration form, submission of catch-up CPE, and payment in the amount of \$100. The payment comprised the \$100 registration fee for the fiscal year 2023-2024. After discussion, Mr. Smith made a motion to reinstate Ms. Hammond's CPA Certificate No. 6611 to active status. Mr. Etheredge seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Mses. Prince and Sheppard-Harris.

8. <u>Initial Approval of Rule Changes</u>:

a. 30-X-1-.01 – Definition of the Practice of Public Accountancy

Mr. Smith made a motion that the Executive Director and the Board Counsel proceed with the rulemaking procedures required in the Administrative Procedures Act to affect the adoption of the proposed amendment to Board Rule 30-X-1-.01. Mr. Schaffers seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Mses. Prince and Sheppard-Harris.

b. 30-X-5-.01 - Retired & Inactive CPAs

Mr. Schaffers made a motion that the Executive Director and the Board Counsel proceed with the rulemaking procedures required in the Administrative Procedures Act to affect the adoption of the proposed amendment to Board Rule 30-X-5-.01. Mr. Etheredge seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Mses. Prince and Sheppard-Harris.

9. Public Hearing - Final Approval of Rule Changes:

Mr. Kintz opened the meeting to a public hearing to discuss the final approval of Rule changes.

a. <u>30-X-2-.01 – Meetings Quorum</u>

Mr. Busby presented the final rule change to Section 30-X-2-.01 of the Board's Rules. There were no comments made regarding the proposed changes to the Board's Rules. Mr. Etheredge made a motion to adopt the final rule changes for Section 30-X-2-.01 of the Board's Rules. Mr. Schaffers seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Mses. Prince and Sheppard-Harris.

b. <u>30-X-4-.01</u> – Examinations

Mr. Busby presented the final rule change to Section 30-X-4-.01 of the Board's Rules. There were no comments made regarding the proposed changes to the Board's Rules. Mr. Schaffers made a motion to adopt the final rule changes for Section 30-X-4-.01 of the Board's Rules. Mr. Smith seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Mses. Prince and Sheppard-Harris.

c. 30-X-4-.02 – Qualifications of Candidates for Certified Public Accountant Examination

Mr. Busby presented the final rule change to Section 30-X-4-.02 of the Board's Rules. There were no comments made regarding the proposed changes to the Board's Rules. Mr. Etheredge made a motion to adopt the final rule changes for Section 30-X-4-.02 of the Board's Rules. Ms. Sheppard-Harris seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Mses. Prince and Sheppard-Harris.

d. 30-X-4-.04 – Passing Grades, Conditioned Subjects, Reexamination, Reapplication

Mr. Busby presented the final rule change to Section 30-X-4-.04 of the Board's Rules. There were no comments made regarding the proposed changes to the Board's Rules. Ms. Sheppard-Harris made a motion to adopt the final rule changes for Section 30-X-4-.04 of the Board's Rules. Mr. Smith seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Mses. Prince and Sheppard-Harris.

e. <u>30-X-7-.01 – Initiation of Proceedings</u>

Mr. Busby presented the final rule change to Section 30-X-7-.01 of the Board's Rules. There were no comments made regarding the proposed changes to the Board's Rules. Mr. Schaffers made a motion to adopt the final rule changes for Section 30-X-7-.01 of the Board's Rules. Mr. Etheredge seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Mses. Prince and Sheppard-Harris.

Mr. Kintz ended the public hearing portion of the meeting.

10. Approval of Jan-Feb-Mar 2024 CPA Examination Grades:

The Board was presented with the AICPA Advisory Grades for the January through March 2024 Uniform CPA Examination. After review, Mr. Smith made a motion to approve the grades as released to candidates. Ms. Sheppard-Harris seconded and the motion carried unanimously.

11. Approval of new CPA Certificates from 15117 through 15140-R:

Mr. Schaffers made a motion to approve new CPA Certificates No. 15117 through 15140-R. Mr. Smith seconded and the motion carried unanimously.

12. Approval of FY2024-2025 Operations Plan:

The Board was presented with the FY2024-2025 Operations Plan. After review, Ms. Sheppard-Harris made a motion to approve the FY2024-2025 Operations Plan as presented. Mr. Schaffers seconded and the motion carried unanimously.

13. Approval of Increase in CPA Exam Section fees:

Mr. Etheredge made a motion to approve the increase in CPE Exam Section fees to \$262.64 per section effective August 3, 2024. Ms. Prince seconded and the motion carried unanimously.

14. Approval of Office Lease:

The Board was presented with a renewal of the office lease with RSA. After review, Mr. Etheredge made a motion to approve the office lease as presented. Mr. Schaffers seconded and the motion carried unanimously.

15. FY202-2024 Delinquencies Update and Analysis:

A statistical summary of FY2023-2024 Delinquencies was presented to the Board. A brief discussion ensued but no action was taken.

16. Complaints Update:

A complaints summary for FY 2009-2010 through 2023-2024 was presented to the Board. A brief discussion ensued but no action was taken.

17. <u>Discussion/Recap of CPE Audit:</u>

A statistical summary of the past few years of CPE Audit was presented to the Board. A brief discussion ensued but no action was taken.

18. Licensee Count:

A statistical summary of the number of Board licensees by category was presented to the Board. A brief discussion ensued but no action was taken.

19. Executive Director Update on Activities:

Mr. Busby updated the Board on activities from the Board office. While reviewing financial projections, the Board discussed possible changes that could be made. After a brief discussion, Mr. Etheredge made a motion for the Board to no longer pay the credit card processing fees to Alabama Interactive and for licensees to pay this charge effective October 1, 2024. Mr. Schaffers seconded and the motion carried on a roll call vote. Voting in favor of the motion were Messrs. Etheredge, Kintz, Schaffers, Smith, and Mses. Prince and Sheppard-Harris.

20. Recap of NASBA Regional Meeting:

Current topics discussed at the NASBA Regional meetings were presented to the Board. A brief discussion ensued but no action was taken.

21. Other Business:

Mr. Garrett informed the Board that an injunction filed earlier in the year had been settled. Mr. Garrett informed the Board that he had filed a motion to dismiss with the courts, which had been granted.

22. Adjournment of Meeting:

The next meeting of the Board is scheduled for Tuesday, September 17, 2024 at 10:00 a.m. at Auburn University in Auburn, AL. There being no further business to come before the Board, Mr. Schaffers made a motion to adjourn. Mr. Etheredge seconded and the motion carried unanimously. The meeting adjourned at 2:45 p.m.
